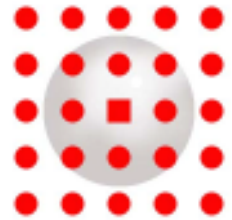

1) Payment and Charges

Call charges as agreed will be invoiced monthly with payment being due in 30 days. Overdue accounts will be charged interest @ 3% per month. Charges will be calculated as per the tariff schedule annexed to this contract. It is the client's responsibility to read and understand the charges.

2) Non-payment/fraudulent use

In the event of fraudulent use or non-payment of airtime AST AIRTIME will suspend the service. Thereafter the SIM card will only be useable after all outstanding charges as per the agreement have been met in full. AST AIRTIME reserve the right to suspend the service at any time, upon the discovery of either of the above two breaches.

3) Unauthorised use

It is the client's responsibility to ensure appropriate safeguards are taken so that any unauthorised use is not allowed. If the unit is stolen please advise us immediately in writing and we will deactivate the SIM Card and blacklist the terminal. All calls made from the SIM Card will be chargeable howsoever caused until deactivated.

4) Re-activation

If re-activation is required and agreed by AST AIRTIME, then AST AIRTIME reserve the right to make a charge of US\$50 payable to AST AIRTIME prior to this service taking place.

5) Monthly subscription

Monthly subscription will be charged as per agreement irrespective of use of the terminal.

6) Duration

This agreement runs for 12 (twelve) months from the date of inception and is binding for that period.

7) Renewal

To allow continued use of the phone AST AIRTIME will automatically renew the agreement unless informed otherwise by the client in writing. Three months notice is required.

8) Transfer of service

In the event that Service Provider withdraws from IRIDIUM operations then Service Provider has the right to transfer or assign this contract for services to another IRIDIUM Service Provider. The intent is to provide uninterrupted services.

9) Disclaimer

No liability or consequential loss will be accepted by AST AIRTIME for any, or all, failure of the system provided. Call records generated by the IRIDIUM Gateway will be considered conclusive evidence of calls made.

10) All services

These contractual terms relate to all IRIDIUM Services provided such as voice, paging, mailbox etc.

11) Value Added Tax

VAT is charged at the current rate and added to the charges quoted herein where applicable.

12) Jurisdiction

This agreement is subject to English law and is not transferable without consent from AST AIRTIME.

13) Exchange rates

AST AIRTIME pays the Gateway in US Dollars hence the exchange rate at the time of invoicing will apply.

14) Activation

For marine systems it is the responsibility of users to ensure that operation does not affect any physical or license requirement applicable to the vessel concerned.

15) **The determination** of tariff charges depends upon the geographical location of the caller. This may be varied depending upon the integral map accuracy of the system and satellite geometry.
